# Technology

What worked?

Teleconferencing, Zoom and Teams when laptops/desktops were state of the art, bandwidth was high and no one else was in the room.

Colleagues on both sides were understanding, courteous, civil and worked well under difficult circumstances.

- WHAT DID NOT WORK
- POOR BANDWIDTH LED TO PROBLEMS UNDERSTANDING EACH OTHER DUE TO LAG. DISRUPTIONS DUE TO FAMILY MEMBERS BEING IN THE ROOM WERE NOT CONSISTENT WITH CONFIDENTIALITY AND SERIOUSNESS
- SOME COLLEAGUES USED THE PANDEMIC AS AN EXCUSE TO RESPOND VERY LATE, INFREQUENTLY OR NOT AT ALL

## Changes in Client-Service Protocol

No personal meetings at office, lunch or social events.

Couriers, fax, telephone and video conferencing only Numerous matters on hold as closing of Small Claims Courts since March 2020 have essentially stopped all progress on matters, therefore invoices are on hold.

Virtually no opportunities to cultivate and maintain client relationships as travel was highly restricted and clients were not in their offices. (Almost everyone working from home)

Decision making that would take days would not require weeks and months of delay as client staff had reduced hours and poor technology and/or access to files.

- CORPORATE CLIENT RAPPORT IS VITAL TO GETTING AND KEEPING CLIENTS THROUGH SOCIAL
  EVENTS, LUNCH AND DINNERS, SPORTS EVENTS AND CONCERTS, POLITICAL EVENTS AND GOLF.
  WITHOUT PERSONAL CONTACT CLIENT GROWTH HAS BEEN FLAT.
- NEW CONTRACTS SIGNED JUST PRIOR TO MARCH 2021 ARE ON HOLD AND LIKELY TO BE CANCELLED OR RENEGOTIATED LEADING TO LOST REVENUE

### IMPACT ON RACIALIZED LICENCEES DURING COVID-19

Leni Yang, Paralegal, Justice by Case



It has not been easy for a majority of us during the COVID-19 Pandemic lockdown that started in March 2020. No one would have known we would be in the same situation almost a year later. Unemployment, Loss of work, reduced hours, loss of support (child care) or working from home, some of us have involuntarily come into difficult situations. Whatever the situation, struggles from self-isolation and lack of socializing with others can have a huge impact on our mental health and more so on racialized persons. The barrier in language and ethnicity can be generally be a challenge for racialized licencees in a normal setting but becomes even more difficult during a pandemic lockdown. Some of the effects can include feeling isolated, feeling excluded, not being heard, having minimal support (emotionally and mentally) and women having a hard time balancing work and family with lack of resources. Whatever the struggle, it is most important during these difficult times to be inclusive and help if you can. You never know the positive impact you could have on someone's life and well-being. Please reach out to any collogues and especially racialized collogues that may show any of the symptoms or may be in difficult situations. Here are some resources that can be very helpful.


